i. Training on the Open Public Meetings Act will need to be scheduled at the next meeting as Director Hinman had technical issues.

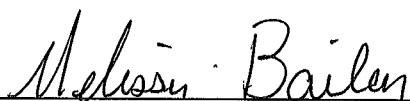
VII. ADJOURNMENT
