I. CALL TO ORDER

The Human Services Committee meeting was called to order by Committee Chair, Carmen Goers, at 4:04 pm on Monday, March 22, 2021 via Zoom.

- Committee Member Janeane La Casse moved to accept the February 22, 2021 meeting minutes. Committee Member Kelly Lindberg seconded the motion. All committee members were in favor of adopting the minutes.

Experts from 4th Quarter reports from Catholic Community Services HOME/WHOME and Katherine and Rita's House, Mary's Place, SKC Mobile Medical, and Sound PATH we included in a short PowerPoint and shared with the Committee Members.

- Joy presented an update on the 2020 Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER is a report submitted to HUD to demonstrate outcomes from CDBG and CDBG-CV funds use in 2020 to support public services, affordable housing and homelessness prevention, specifically the City's Housing Repair program, HealthPoint's Medical and

Dental program, HealthPoint COVID Testing and Treatment, and Multi-Service Center's Emergency Subsistence program, and two low to moderate income area benefit activities to improve pedestrian accessibility.

- Committee Member asked about the status of the open Human Services Committee positions. Kyla let the Committee know that Human Services staff is continuing to share and information about the Committee in a number of community groups and forums and welcomes additional suggestions of where to share the posting. Some of the inquiries staff have fielded have expressed concerns about being able to commit to the three year term for the Committee.
