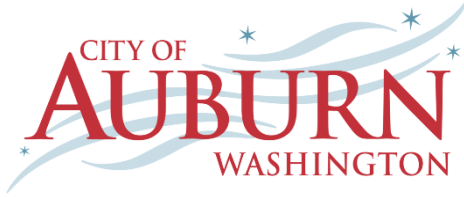

Also, advised the Commission about the postponement of the Commander Promotional Exam at the request of the Sergeant's union group.

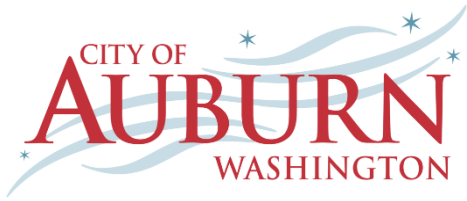
**ADJOURNMENT**

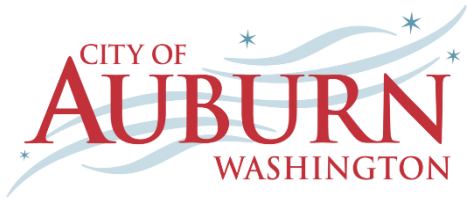
