The nomination of the 2026 Chair Pro Tem position has been moved to the March Commission meeting.

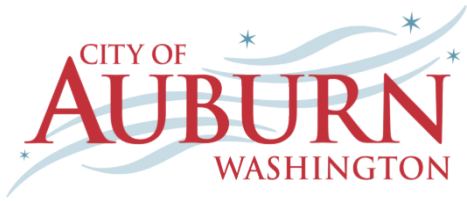

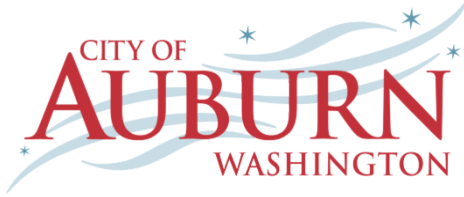

Motion carried unanimously, 2-0.

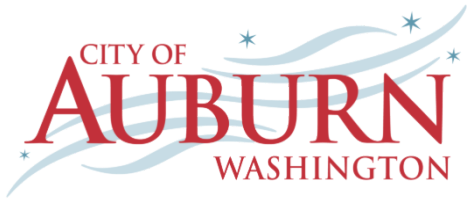
