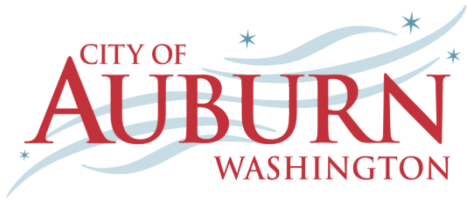

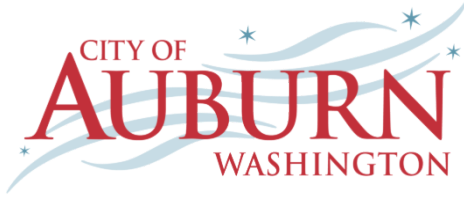

There was no new business discussed at this meeting.

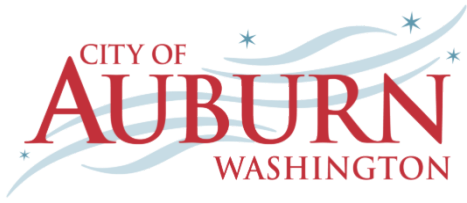

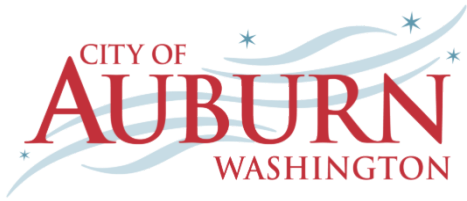
