Sergeant promotional testing is anticipated within the next few months, with an eligibility list scheduled for certification at the December Commission meeting.

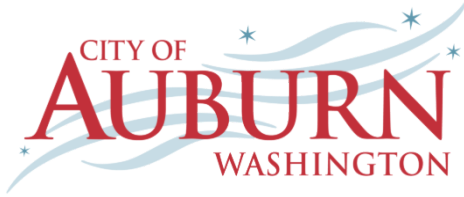
